APPLICATION FOR REGISTRATION AS A CITIZEN OF THE REPUBLIC OF CYPRUS UNDER SECTION 5 (2) OF THE LAW MADE BY A PERSON WHO HAS BEEN MARRIED TO A CITIZEN OF THE REPUBLIC OF CYPRUS OR WAS THE SPOUSE OF A PERSON WHO WOULD, BUT FOR HIS DEATH, HAVE BECOME OR BEEN ENTITLED TO BECOME A CITIZEN OF THE REPUBLIC OF CYPRUS.
