<sup>†</sup> In order to become a citizen of the Republic of Cyprus under Section 2 of Annex "D" a person MUST be a citizen of the United Kingdom and Colonies who on the 16<sup>th</sup> of August 1960, possessed any of the qualifications set out in paragraph 2 of Section 2 of Annex "D" (which are the qualifications set out in paragraph 7 of this Form) and was ordinarily resident in the Island of Cyprus at any time in the period of five years immediately before the 16<sup>th</sup> of August 1960).

<sup>‡</sup> The countries so specified are: the United Kingdom, a colony, protectorate, protected state or United Kingdom trust territory or the territory of any country within the British Commonwealth of Nations having separate citizenship from that of the United Kingdom and Colonies or any dependency of that territory.
